Privacy Policy

This Privacy Policy ("Policy") applies to www.buddinbakery.com, and Buddin' Bakery LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.buddinbakery.com. The Company's website is a E-commerce, information site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

-First and last name -Mailing address -Email address -Phone number

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

The Company may also collect anonymous demographic information, which is not unique to you, such as your:

-Age -Gender -Race -Religion

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

In those cases, your unique personally identifiable information (email, name, address, phone number) is not transferred to the third party. Tracking User Behavior

Automatically Collected Information

The Company may automatically collect information about your computer hardware and software. This information can include your IP address, browser type, domain names, access times, and referring website addresses. Use of Cookies

The Company's website may use "cookies" to help you personalize your online experience. A

- -Exercise free speech, ensure the right of another consumer to exercise his or her right of fre
- -Comply with the California Electronic Communications Privacy Act;
- -Engage in public or peer-reviewed scientific, historical, or statistical research in the public ir
- -Enable solely internal uses that are reasonably aligned with your expectations based on your
- -Comply with an existing legal obligation; or
- -Otherwise use your personal information, internally, in a lawful manner that is compatible wi
